The system has enabled Modus Furniture to integrate its leased 250,000 square foot warehouse, which processes about 30% of its orders, onto a common system for improved inventory visibility. Receiving, putaway, bar coding, labeling, bin tracking, pick tickets and bills-of-lading have all been automated for improved warehouse efficiencies. Apprise Distribution's strong direct ship capabilities also enable Modus Furniture to seamlessly manage its high volume of direct ship orders to larger furniture merchandisers, such as Levitz, which account for up to 70% of its sales. Comprehensive inventory planning, forecasting, purchasing and allocation provide Modus Furniture with tools to better handle its import operations and ensure timely availability of products for its customers.

“Inventory accuracy improved from 80% to 95% within the first year,” stated Richey. Automatic order acknowledgements to customers, with notifications to appropriate internal personnel, have reduced manual and often overlooked work processes and improved order accuracy. Improved communications and real-time data visibility in accounts receivable and collections have streamlined work flows, automated tasks, reduced chargebacks and significantly reduced past due receivables.

“Before we implemented Apprise Distribution, over 25% of our accounts receivable were greater than 90 days outstanding,” said Richey. “With Apprise Distribution, that number has literally dropped to 0%.”

As its operations continue to grow and evolve, Modus Furniture plans to leverage additional capabilities within the Apprise Distribution system including distribution resource planning (DRP), which it plans to use to automate its forecasting, planning and purchasing processes, improve its inventory turn over, and reduce stock outs. Newer technologies, such as Apprise® EDI Solutions and Apprise® Wireless Warehouse, will help automate processes that are currently manually intense for further efficiency gains. In addition, Modus Furniture plans to open a new warehouse in Asia and integrate it within the Apprise Distribution system.
